

As the state government grapples with a budget crunch for protection and conservation of historic monuments, it has begun roping in private donors to undertake the upkeep of these sites like forts. The Sinhagad fort near Pune has seen four security guards being deployed since earlier this year near the samadhi (monument or resting place) of iconic warrior Tanaji Malusare, who wrested the fort for Chatrapati Shivaji Maharaj from the Mughals in the Battle of Sinhagad (1670). The personnel undertake the security, upkeep and cleanliness of the site. These guards have been paid for by the Chate Coaching Classes chain in the first such initiative.

On Wednesday, the directorate of museums and archaeology will sign an agreement with the Pune-based
